Answer Key

Answers to True or False

- 1. **False.** Hazing can also occur through psychological actions, such as demeaning language or efforts to separate the individual from the group in some way for a period of time.

- 3. False. Hazing can occur at all levels of military rank and service status.
- 4. **False.** The distinguishing factor of hazing versus other forms of harassment is that hazing is intended to go on for a specific period of time where at the end the individual is meant to feel belonging to the group.

- 6. **False.** Regardless of an organization's history or traditions, hazing can be harmful and should not be tolerated.

- 8. **False.** It is still considered hazing, even if the individual consents to be a part of the activities.

Answers to Scenarios

- 1. Hazing. This is hazing because it can be inferred that those who are able to prove their endurance would be recognized as stronger and eligible to be part of the group.
- 2. Hazing. This is considered hazing because it is understood that the participants are earning a place in the group.
- 3. Other harassment. This behavior is considered other harassment (specifically retaliation) because it is meant to isolate and exclude the target for an indefinite amount of time.
- 4. Training. This activity would be considered reasonable and a component of training. It is intended to give the individuals an opportunity to improve upon critical training knowledge which they had not previously acquired.
